Amey response times have increased over the past months and are now nearly on target. The Boundary commission have recommended a reduction of 50 MPs with nil effect on the Cotswolds, although there will be a slight change in the constituency area.
Cllr Hicks concerned that the Tetbury Civic Society are pushing for adoption of the Atkins report in the Neighbourhood plan which if agreed would increase heavy traffic on Charlton Road/New Church Street.
