22/03495/FUL Full Application for Mixed use development comprising healthcare facility, 27 dwellings (including 11 affordable units), landscaping, site access, internal estate road and associated works at Land West Of Worwell Farmhouse Cirencester Road Tetbury *After much discussion Cllrs agreed to request an extension on time to respond to the application.* **22/03767/FUL** Full Application for Erection of an observatory/folly within the grounds of the house and other associated works at Charlton Down House Charlton Down Tetbury *Cllrs have concerns regarding the height of the proposed building and agreed it would be helpful to visit the site.*

 - **22/03145/FUL** Full Application for Change of use and conversion of commercial warehouse into residential dwelling and associated works at The Warehouse Builders Yard Longfurlong Lane Tetbury Gloucestershire

'Tetbury Upton Parish Council agree the building is in urgent need of refurbishment, but feel the proposed conversion of a builders warehouse to a residential dwelling is totally inappropriate due to the close proximity of other commercial buildings and a insubstantial entrance and exit on to Longfurlong Lane. Cllrs are also concerned that the foundations of an industrial building would not be adequate for a residential building'
